Wait to send this form until all relevant parties' full names are provided and any potential conflicts of interest are ruled out. This process ensures that when you swear or affirm the affidavit, all information is accurate and complete.

You will need to bring the original documents to your signing appointment, however copies are sufficient at this stage.
